

## UnitedHealthcare (UHC) Medical Plan Changes for the 2024 Benefits Plan Year

- Effective April 1, 2024, plans with the Advantage 4 copay structure, with the exception of South Carolina (SC), will change to the Advantage 3 copay structure, as outlined in the chart below.
